

Customs formalities in EMSWe

- PoUS "Phase 2": CGM + PPA + SDA + SDD + CAR messages
- AES domain: REN + EXT + EXS messages + MFX
- PNO (PN) message
- TSD (TS) and <u>TSR</u> (TS with reduced data set) messages
- NAC (AN) message
- ETD Electronic Transport Document as simplification for transit movement (at departure TRD message and at arrival TRA message)





Mapping with TAXUD messages

- The mappings of the PoUS, AES and ICS2 formalities with their equivalent TAXUD messages are provided in Annex 5.
- The mapping of MFX with the AES message IE547 has been added.
- The mapping files should be used as reference by the MNSW (or other relevant national system) developers to translate the received formalities to the corresponding TAXUD messages or the equivalent national customs messages.



Customs open issues

- Presentation of the open issue related to customs, listed in the Message Implementation Guide (MIG) of the EMSWe (main document) – Annex 1 (only 5 remained open).
- **Objective:** to close as much as possible and keep track of the others for future developments.



PoUS Phase 2 formalities

The list below indicates the PoUS formalities and the corresponding TAXUD messages.

- CGM (Customs goods manifest) corresponding to IEP09
- PPA (Presentation of the proof at arrival) corresponding to IEP04
- **SDA** (Supplementary Documents at Arrival) corresponding to **IEP56**
- **SDD** (Supplementary Documents at Departure) corresponding to **IEP49**
- CAR (CGM Amendment Request) corresponding to IEP61

The mapping of the PoUS formalities with their equivalent TAXUD messages are provided in Annex 5. The mapping files should be used as reference by the MNSW developers to translate the received formalities to the corresponding TAXUD messages.

PoUS Phase 2 messages CGM - PPA - SDA - SDD - CAR

- Periodical meetings with PoUS Team have been organised to define the possible connection between NMSW and PoUS systems:
 - connection between MNSW and central PoUS (short path)
 - connection between MNSW and National Customs + connection between National Customs and central PoUS (long path)




PoUS Phase 2 messages CGM - PPA - SDA - SDD - CAR
